All the Candidates, having their name in the Merit List, attached at Annexure-I and have not taken admission, so far, in MCA Programme (CET Code: 105) for the academic year 2023-2024, in any other Colleges (including USICT) of GGSIP University, and are interested for taking admission at Bharati Vidyapeeth's Institute of Computer Applications and Management (BVICAM), New Delhi, for MCA Programme under Management Quota, are hereby informed to report for the Counselling, as per the details and the schedule, mentioned hereunder:-

Procedure for Counselling for Admission

Candidates having reported for the Counseling, as per the afore-mentioned schedule, shall first be required to get all their documents verified, to ascertain their eligibility. After successful document verification, all the eligible candidates shall be called strictly on merit, based upon the aggregate percentage of marks obtained in qualifying examination, for allotment of seats, strictly as per their choices filled in the Preference Sheet as per Appendix 11(A) of GGSIP University Admission Brochure. Order of preference of the CETs shall be as first preference to NIMCET Qualified Candidates, second preference to GGSIPU-CET Qualified Candidates and third preference to NTA PG-CUET Qualified Candidates. Counseling / Admission shall continue till the vacancy remains and shall be stopped as and when the seats are filled up. Please note that mere invitation for Counseling / having found eligible for admission / having paid the Counseling Participation Fee / having participated in the Counseling does not guarantee any admission.

<u>Candidates shall bring the following documents (Originals) for verification with 03 sets of self attested Photocopies:</u>

- 1. Proof of having paid the Non-refundable Counseling Participation Fee of Rs. 5,000/- (Rs. Five Thousands Only) latest by 13-09-2023 upto 04:00 p.m.
- 2. Notarized Affidavit on Rs. 10/- stamp paper, as per Appendix A (Original & Photocopies).
- 3. Demand Draft / Pay Order of Rs. 02,01,600/- Rs. Two Lakhs One Thousand and Six Hundred Only) in favour of DIRECTOR, BVICAM payable at New Delhi. To avoid payment delay and other payment related last minute problems, on the spot, online payment shall not be permitted.
- 4. Proof of Application and payment of Fee (Rs. 1,500/- at GGSIPU Portal
- 5. NIMCET / GGSIPU-CET / PG-CUET Admit Card (Original & Photocopies).
- 6. NIMCET / GGSIPU-CET / PG-CUET Score Card.
- 7. Original Certificate and Mark Sheet of X class (Original & Photocopies).
- 8. Original Certificate and Mark Sheet of XII class (qualifying examination) (Original & Photocopies).
- 9. Original Certificate and Mark Sheets of Graduation (Original & Photocopies).
- 10. College Leaving/Transfer Certificate from the College last attended (Original & Photocopies).
- 11. Migration Certificate (Original & Photocopies).
- 12. Medical Certificate: All students shall be required to submit a Medical Certificate in Appendix 5 of GGSIP University Admission Brochure (Original & Photocopies).
- 13. Admission Verification Form in Appendix 6 of GGSIP University Admission Brochure (Original & Photocopies).
- 14. Undertaking by the student with respect to anti-ragging and undertaking by parent/guardian with respect to anti-ragging as per Appendix 7 & 8 of GGSIP University Admission Brochure (Original & Photocopies).
- 15. Conduct and Character Certificate (Original) from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer (Original), not more than 06 (six) months old (Original & Photocopies).
- 16. In case of gap year, the candidate is also required to submit a notarized Gap Year Affidavit on stamp paper of Rupees Ten (Original & Photocopies).
- 17. Reserved Category Certificates (Original) along with applicable Undertaking, as per the Proforma of GGSIP University Admission Brochure (Original & Photocopies).
- 18. Aadhar Card of the Candidate (Original & Photocopies).
- 19. Aadhar and PAN Card of the Father (Original & Photocopies).
- 20. 10 pcs. of passport size recent colour photographs of the candidate, showing front view of full face with white background. Photographs with any dark glasses/polaroid prints/Computer Prints will not be accepted.
- 21. 01 passport size recent colour photograph of Father and Mother.
- 22. Certificate in support of having passed Qualifying Examination from Delhi to establish Category like Delhi/Outside Delhi (Original & Photocopies).
- 23. Preference Sheet as per Appendix 11(A) of GGSIP University Admission Brochure (Original & Photocopies).

Important Notes:

 Candidates, who have already taken admission in MCA Programme (CET Code: 105) for the year 2023-2024, in any other Colleges (including USICT) of GGSIP University, under 10% Management Quota through Online/Offline Counselings of

Colleges shall not be eligible for consideration under Management Quota seats at BVICAM, New Delhi. Further, the candidates, who have already taken admission in MCA Programme (CET Code: 105) for the year 2023-2024, in any other Colleges (including USICT) of GGSIP University, under 90% Merit Seats through Online/Offline Counselings of GGSIPU, upto Round 03, may be eligible for consideration under Management Quota seats at BVICAM, New Delhi, only if they submit an Affidavit in prescribed format, as per Appendix-A, that if he/she becomes successful in getting seat under Management Quota, at BVICAM, New Delhi, that he /she shall withdraw his/her Admission, which he/she has already taken in MCA Programme (CET Code: 105) for the year 2023-2024, in any other Colleges (including USICT) of GGSIP University, under 90% Merit Seats through Online/Offline Counselings of GGSIPU, upto Round 03 and the copy of the Withdrawal Receipt shall be submitted by 14-09-2023 upto 05:00 p.m. on E-Mail: mca@bvicam.ac.in, failing which the Offered Admission at BVICAM, New Delhi, under Management Quota, shall automatically stand cancelled and the seat shall be considered as vacant, which shall be offered to any other candidate during 2nd Counseling to be held on 15-09-2023. This means that candidates under NOT ADMITTED Category only shall be allowed to take Final Admission in Management Category.

- 2. Candidates once admitted under Management Quota seat shall not be eligible to take admission in any other colleges (including USICT) affiliated to GGSIPU.
- 3. The Fee deposited for admission under Management Quota Seat shall not be refunded, in any case.
- 4. Entry Gate shall be open by 09:00 a.m. Counseling process shall start at 10:00 a.m. (sharp), strictly as per afore-mentioned schedule and candidates coming late i.e. after 10:00 a.m., will be allowed, only for remaining vacancies, after their successful document verification.
- 5. Along with the candidate, only one parent (either Father or Mother) shall be allowed to enter the Institute's premises. No relatives, whosoever, are allowed to enter the Institute's premises. For verification of Identity of parent at the Entry Gate, kindly carry Original Valid Photo ID Card such as Aadhar Card / Passport / PAN / Voter ID Card / Driving License / etc.).
- 6. Laptop/mobile phone/cellular smart watches/other electronics gazettes are strictly prohibited to enter in the Institute's premises. So, it is the responsibility of the candidate/parent not to carry any such items or make the required arrangement to keep these items outside the campus, before entering into the campus. Institute will have no responsibility, whatsoever, for the same.
- 7. It is mandatory for the candidates, aspiring to take admission, to physically participate in the counseling and be present in person, till the allotment of the seat, failing which, the right of the candidate to participate in the counseling shall automatically stand cancelled. No one else; parents/relatives shall be allowed to impersonate the candidate to participate in the Counseling.
- 8. After successful document verification, all the eligible candidates shall be called strictly on merit, based upon the aggregate percentage of marks obtained in qualifying examination, for allotment of seats, strictly as per their choices filled in the Preference Sheet as per Appendix 11(A) of GGSIP University Admission Brochure. Order of preference of the CETs shall be as first preference to NIMCET Qualified Candidates, second preference to GGSIPU-CET Qualified Candidates and third preference to NTA PG-CUET Qualified Candidates.
- 9. Seat allotment shall be confirmed for provisional admission, only after depositing the required DD/Pay Order (for the total fee), instantly on the spot, failing which

- the offered seat shall automatically stand cancelled and the same shall be allotted to the next candidate in merit.
- 10. The entire session of the Counseling shall be video graphed.
- 11. Only serious candidates, aspiring to participate in the Counseling, should pay Non-refundable Counseling Participation Fee of Rs. 5,000/- (Rs. Five Thousands Only). The Counseling Participation Fee shall not be refunded, in any case, even if the candidate fails to attend the counseling, in person, or attend the counseling but could not get any seat.
- 12. All admissions are provisional subject to ratification by GGSIP University.
